The Agreement

These terms of engagement are between The Sponsoring Company (“you” or “the Sponsor”) and Ruby Australia Incorporated (ABN 58 789 561 96)

Sponsoring RubyConf Australia 2015 does not guarantee a member of The Sponsor’s company or organisation a speaker position at the conference. Speakers will be determined independently by the RubyConf Australia 2015 organisers.

If tickets are included in a Sponsorship level, the Sponsor must inform Ruby Australia Incorporated of the names of conference attendees at least 14 days prior to the conference date.

Payment terms

The fee is calculated at the rate indicated at each sponsorship level on page 1 of this document. Following execution of this Agreement, an invoice will be issued to the Sponsor and payment is due 30 days following issuance of the invoice. Only upon receipt of the executed Agreement is the Sponsorship position confirmed and until such time the Sponsorship positions remain available.

If any of the levels of sponsorship are over-subscribed, a small Ruby script will be used to randomly choose which sponsors get the slots.

Cancellation Policy

If for any reason the Sponsor wishes to cancel their sponsorship of RubyConf Australia 2015, the maximum refund they will receive is 60% of the total sponsorship value paid by the date of cancellation. Should the Sponsor cancel their sponsorship within 30 days of the conference date, the maximum refund they will receive is 10% of the total sponsorship value. If for any reason Ruby Australia Incorporated cancels the sponsorship, the maximum refund the Sponsor will receive is 90% of the value of the sponsorship paid by the date of the cancellation.
